Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

While CSES LLP's carbon footprint per employee (1.2 tonnes of CO_{2e} per employee) is much lower than the average office-based organisation (3.5 tonnes of CO_{2e} per employee according to Carbon Footprint²), we will aim to reduce carbon emissions over the next five years to **1 tCO_{2e} per employee by 2028**. This is a reduction of **17% per employee**.

However, from 2023, CSES will offset all emissions on an annual basis, thereby achieving Net Zero carbon emissions.

Carbon Reduction Projects

Completed / Future Carbon Reduction Initiatives

As highlighted above, 2022 is the first year in which CSES LLP has measured its carbon emissions. This draft Carbon Reduction Plan therefore presents the future carbon reduction initiatives that will be implemented in the coming year with the aim of reducing our carbon emissions in line with the above target:

- Develop a strategy to specifically monitor and reduce carbon emissions and ensure CSES LLP achieves Net Zero carbon emissions. This will include a commitment to offset all carbon emissions on an annual basis.
- Changes to the company travel policy to reduce non-essential travel. Primarily, this will consider the possibility to reduce the number and distance of flights, which in 2022 comprised more than 50% of the carbon emissions generated by CSES LLP.
- Changes to the company travel policy to encourage, where travel is necessary, the use of modes of transport with lower carbon emissions.
